#### REQUESTED ACTION

Adopt Resolution No. 2018-001 to adopt a conflict of interest code for the South Kings GSA.

#### **DISCUSSION / RECOMMENDATION**

California's Political Reform Act requires every local government agency, including groundwater sustainability agencies, to adopt a conflict of interest code and review that code at least every two (2) years. A conflict of interest code tells public officials, government employees, and consultants ("designated employees") what financial interests they must disclose on their Statement of Economic Interest (Form 700). Financial interests may include investments, business positions, income, loans, and gifts. A conflict of interest code requires different levels of disclosure ("disclosure categories") for the designated positions, providing the basis or the transparency that the Political Reform Act requires of public officials.

#### **RESOLUTION 2018-001**

## A RESOLUTION OF THE SOUTH KINGS GROUNDWATER SUSTAINABILITY AGENCY OF INTENT TO ADOPT A CONFLICT OF INTEREST CODE

**WHEREAS**, the Political Reform Act (Government Code section 87100, et seq.) requires state and local government agencies to adopt and promulgate conflict of interest codes; and

**WHEREAS**, the South Kings Groundwater Sustainability Agency ("South Kings GSA") desires to adopt its initial conflict of interest code to be routinely reviewed and updated as necessary to comply with applicable law; and

**WHEREAS**, in accordance with state law the South Kings GSA has prepared the attached Conflict of Interest Code; and

**WHEREAS**, the Conflict of Interest Code contains required disclosure categories and a list of designated officials and employees who must file statements of economic interest.

#### NOW, THEREFORE, BE IT RESOLVED by the South Kings GSA that:

- 1. The Conflict of Interest Code for the South Kings GSA is hereby adopted as set forth in Exhibit "A" attached to this Resolution.
- 2. Those officials and employees designated in Appendix "A" of Exhibit "A," whether elected, appointed, or otherwise hired, shall file statements of economic interests, upon assuming office, leaving office, and during each year in office, with the Secretary of the South Kings GSA, and such statements shall be retained available for public inspection and reproduction pursuant to Government Code section 81008. Upon receipt of the statements for the Board of Directors, the Secretary of the South Kings GSA shall make and retain a copy and forward the original to the Clerk of the Board of Supervisors of the County of Fresno, as the code reviewing body and filing officer pursuant to Government Code sections 82011 and 87500.

# SOUTH KINGS GROUNDWATER SUSTAINABILITY AGENCY CONFLICT OF INTEREST CODE

The Political Reform Act (Government Code Section 81000, et seq.) requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation (2 California Code of Regulations Section 18730) that contains the terms of a standard conflict of interest code, which can be incorporated by reference in an agency's code. After public notice and hearing, the standard code may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations Section 18730, and any amendments to it duly adopted by the Fair Political Practices Commission, are hereby incorporated by reference. The terms of the standard code incorporated herein, along with the attached appendices designating positions (Appendix "A") and establishing disclosure categories (Appendix "B"), will constitute the conflict of interest code of the South Kings Groundwater Sustainability Agency.

Individuals holding designated positions shall file their statements of economic interests with the Secretary of the South Kings Groundwater Sustainability Agency, who will make the statements available for public inspection and reproduction. (Government Code section 81008). Upon receipt of the statements for the Board of Directors, the Secretary of the South Kings Groundwater Sustainability Agency shall make and retain copies and forward the originals of these statements to the Clerk of the Board of Supervisors of the County of Fresno as the filing officer.

Upon receipt of the statements, the Clerk of the Board of Supervisors of the County of Fresno shall make and retain a copy of each statement and forward each original to the Fair Political Practices Commission. The copies retained shall be available for public inspection and reproduction. (Government Code section 81008)

#### APPENDIX A

#### **DESIGNATED POSITIONS**

<u>Designated Positions</u>	Disclosure Category
Board Members	1
Secretary	1
General Counsel	1
Consultants	As determined by the Board

The Board may determine in writing that a particular consultant, although a "designated position," is hired to perform a range of duties that is limited in scope and thus is not required to comply fully with the disclosure requirements in this section. Such written determination shall include a description of the consultant's duties and, based upon that description, a statement of the extent of disclosure requirements. The Board's determination is a public record and shall be retained for public inspection in the same manner and location as this conflict-of-interest code. (Government Code section 81008.)

#### APPENDIX B

#### **DISCLOSURE CATEGORIES**

Economic interests, including investments and business positions in business entities, interests in real property, and all sources of income (including loans, gifts, and travel payments), must be disclosed in accordance with applicable Fair Political Practice Commission (FPPC) guidelines.

"Jurisdiction" means the South Kings Groundwater Sustainability Agency. Real property is deemed to be within the jurisdiction if the property or any part of it is located in or within the boundaries/management areas of the South Kings Groundwater Sustainability Agency.

Individuals holding designated positions must report their interests according to their assigned disclosure category.

#### Disclosure Category 1

Interests in real property located within the jurisdiction or within two miles of the boundaries of the jurisdiction or within two miles of any land owned or used by the agency; and investments and business positions in business entities, and income, including loans, gifts, and travel payments, from all sources.

#### <u>Disclosure Category 2</u>

Interests in real property located within the jurisdiction or within two miles of the boundaries of the jurisdiction or within two miles of any land owned or used by the agency.

#### Disclosure Category 3

Investments and business positions in business entities, and income, including loans, gifts, and travel payments, from sources, that provide services, supplies, materials, machinery, or equipment of the type utilized by the agency.

#### Disclosure Category 4

Investments and business positions in business entities, and income, including loans, gifts, and travel payments, from sources, that provide services, supplies, materials, machinery, or equipment of the type utilized by the designated position's division or department.

#### Disclosure Category 5

Investments and business positions in business entities, and income, including loans, gifts, and travel payments, from sources, that filed a claim against the agency during the previous two years, or have a claim pending.

#### Disclosure Category 6

Investments and business positions in business entities, and income, including loans, gifts, and travel payments, from sources of the type to request an entitlement to use agency property or facilities, including, but not limited to a license, utility permit, and/or station vendor permit.
