Call to order by Chair: Chairman Palomar called the meeting to order at 4:01pm.

Approve Minutes: Member Scheline motioned, seconded by Member Ray, to approve the minutes from the August 24, 2020 Public Safety Committee meeting as prepared by City Clerk Abigail Palsgaard. The motion passed by unanimous voice vote in favor of those members present.

Camera Project Update

Member Pursell, Jr. said that they are finishing up the cameras from last fiscal year. An additional \$10,000 will get an about an additional 15 cameras. The committee discussed the project. Chairman Palomar said that it is an important project and it is good that there is a strong infrastructure. Member Sembritzki said that all other concerns are being addressed and that he supports the camera project. Member McGuire asked if they are at schools. Member Pursell, Jr. said they can be positioned around schools, but not at schools. They are looking into high volume and high liability areas. The Committee asked that the Police Department and Kingsburg Media Foundation is available at their next meeting to discuss the use of the \$10,000.

Member Pursell, Jr. motioned, seconded by Member Latham, to allocate the \$10,000 to the police department camera project. The motion passed by unanimous voice vote in favor of those members present.

Other Business

Chairman Palomar asked for an update on the crosswalk striping. The committee discussed the crosswalk at 18th.

City Clerk Palsgaard mentioned that there will be a vacancy with Member Pursell, Jr. becoming a council member in December 2020.

The Committee said they are excited about the camera project and are grateful for Council Member Dix who pursued a budget for the Committee.
