

**COMMUNITY SERVICES COMMISSION**  
**REGULAR MEETING**  
**FEBRUARY 27, 2019**

**Call to Order** – AT 6:38PM the Community Services Commission meeting was called to order.

**Commissioners Present** – Moreno, Bratton, Chambless, Guerra, Bethel and Student Commissioner Saneh Kelon.

**Public Comments** – There were no citizens present who wished to comment at this time.

**Approval of Minutes** – Commissioner Bratton made a motion, seconded by Commissioner Chambless to approve the minutes from the January 23, 2019 Community Services Commission meeting. The motion carried by unanimous vote of those Commissioners present.

**Fugazzi's Fund Raiser Report** – Fund raiser did not raise as much as the first fund raiser, we will receive a check for \$188.00. There were a few glitches with the wait staff but in the end, there was a little money to go towards the skate park. Community Services Director Castaneda stated that he may speak with Heather the manager and see if we can give it another try.

The next fund raiser will be in March at Stacked Bar and Grill.

**Dog Park Update** – Mr. Castaneda reminded the commissioners of the conversation with Wabo about partnering with the City and enhancing landscaping, irrigation and placing vines on the back wall at the Dog Park. The City will make contact with Wabo Construction in the spring to begin the process.

The Commissioners suggested having a community service day at the dog park and ask service groups to participate as well. Will talk with Leslie from Wabo to coordinate this effort.

Had a conversation about putting unused fire hydrants in the dog park, Public Works has the hydrants, and we could ask service groups to paint them.

Richard Smith who owns a local radio station is interested in purchasing the radio tower at the entrance to the dog park and would like to utilize the radio tower for his station. Would possibly fund a bathroom and LED lights on the tower.

Suggested that the money he would spend on bathrooms and lights could be used for a small dog area and an additional entrance.

**Athwal Park Update-**

Commissioner Bratton had a skate park subcommittee meeting at Fugazzi's which included

Council Liaison Jewel Hurtado, Commissioner Bratton and Commissioner Jenn Guerra.

Mr. Castaneda stated that we are still waiting on bids for Athwal Park, he stated that City Engineer Dave Peters is thinking late March they should be in and we could start breaking ground in April.

Once we start the groundbreaking, we can go back to prior grant applications and reapply, once we show that the park is actually moving forward.

The Representative from Gametime met with Adam and he showed her the play structure the commission chose. Her concern is whether there is room around the large play structure for small pieces.
