KINGSBURG CITY COUNCIL REGULAR MEETING AUGUST 15, 2018 – 6:00 P.M.

## 6 P.M. REGULAR SESSION MEETING:

Invocation was given by Pastor Jeff Nathan of the Kingsburg Refinery Church, followed by the Pledge of Allegiance led by Mayor Michelle Roman.

**Call to Order and Roll Call** – At 6:05 P. M. Mayor Michelle Roman called the regular meeting of the Kingsburg City Council to order.

**Council Members present:** Laura North, Staci Smith, Sherman Dix, Bruce Blayney, and Mayor Michelle Roman.

**Staff present:** City Manager Alexander Henderson, City Attorney Michael Noland, City Clerk Abigail Palsgaard, Finance Director Alma Colado, and Police Chief Neil Dadian.

**Public Comments:** David Keyes, Candidate for Fresno County Auditor-Controller, thanked the City of Kingsburg for its support in the primary election and the run-off in November.

**Approve Agenda:** A motion was made by Council Member Blayney, seconded by Council Member Smith, to approve the Agenda, as published. The motion carried by unanimous voice vote.

**Consent Calendar:** A motion was made by Council Member Dix, seconded by Council Member North, to approve the items appearing on the Consent Calendar.

## Regular Calendar

**Community Development Block Grant Presentation**- Staff Report prepared by City Manager Alexander Henderson

Presentation by Kristi Johnson, Fresno County Department of Public Works, Planning and Community Development

City Manager Alexander Henderson reviewed past CDBG projects. He pointed out that we have about \$185,000 which we can bank or spend this year. A resolution would have to be in by the end of September.

Kristi Johnson explained that to qualify the block needs to be 51% low income. Kingsburg is at 38% overall. Seniors and disabled people automatically qualify. One block in Kingsburg qualified.

Council Member Dix asked about using the funds for slum blight projects. Yvette Quiroga.

said that if it is in a low to moderate income neighborhood, we can do it as a one-time thing if it is an urgent need.

Council Member Dix asked about the façade program. He stated that he would like to use these funds to promote downtown. Ms. Quiroga said that emergency/urgent projects would be ok if it is in the downtown.

Council Member North asked about a potential social project with volunteers from the senior center and Marion Villas interacting with kindergarteners at Washington School. Ms. Quiroga said yes, you would want to promote the benefit to the seniors.

Mayor Roman stated that Council will discuss funding options with staff and bring this matter back in September.

Crime Statistics Report for the Month of July 2018 and General Police Department Update-Crime Statistics Report prepared by Kingsburg Police Department Records Supervisor Corina Padilla, presented by Kingsburg Police Chief Neil Dadian.

Chief Dadian pointed out that vehicle burglaries are still up. He explained that it is difficult to make arrests because there is not a lot of evidence. He stated that the Department is working on several complex cases. He spoke about staffing and hiring.
