CPR and First Aid Classes Update

Firefighter Paramedic Dariuss Rodriguez presented regarding CPR and First Aid Classes. The Fire Department purchased new equipment to train and the department has become an American Heart Association training site. The Fire Department has been training first responders and purchased 7 AEDs that will be installed throughout our community. The Fire Department will help train people in the area so they can use it if needed. They will start offering CPR/AED/first aid classes to the public. Cost is \$85, 8 hours long. Class size is 6 people. Discussed AEDs at the high school. Hoping to get the young people a look into health care and first responders. Chairman Palomar asked how long the certifications are good for. Firefighter Paramedic Rodriguez said they are good for two years. Chairman Palomar would like to reach out to the big companies in Kingsburg to promote having employees trained.

Other Business-

Member Sembritzki asked how the cameras working out. Chairman Palomar said the Police Department are happy with the cameras.

Chairman Palomar said he is concerned with accidents on the freeway. It should be done in July.
